

**RESOLUTION AUTHORIZING DISMISSAL
OF PART-TIME EDUCATIONAL SUPPORT PERSONNEL**

WHEREAS, the Board of Education of Urbana School District #116, County of Champaign, State of Illinois, has determined to decrease the total number of part-time educational support personnel employed by the Board of Education and discontinue some particular type of educational support personnel services in the School District; and

WHEREAS, the Board of Education has determined that the part-time educational support personnel hereinafter set forth shall be dismissed and not reemployed for the 2014-2015 school term as a result of the decision by the Board of Education to decrease the total number of part-time educational support personnel employed by the Board of Education and discontinue some particular type of educational support personnel services in the School District, pursuant to Section 5/10-23.5 of The Illinois School Code.

NOW, THEREFORE, Be It Resolved by the Board of Education of Urbana School District #116, County of Champaign, State of Illinois, as follows:

Section 1: That the following part-time educational support personnel are hereby removed or dismissed and not reemployed for the 2014-2015 school term, in conformance with the Exhibits attached hereto and made a part hereof, because of the decision by the Board of Education to decrease the total number of educational support personnel employed by the Board of Education and because of the decision by the Board of Education to discontinue some particular type of educational support personnel services in the School District:

Section 2: That the President and Secretary of the Board of Education are hereby authorized and directed to send the educational support personnel hereinabove set forth a written notice of dismissal by first class mail at least **thirty (30) days** before the employees' last day of employment, which notice shall be substantially as set forth in the Exhibits attached hereto.

Section 3: That the President and Secretary of the Board of Education are hereby authorized and directed to send the educational support personnel hereinabove set forth a written notice of dismissal by certified mail, return receipt requested, at least

thirty (30) days before the employees' last day of employment, which notice shall be substantially as set forth in the Exhibits attached hereto.

Section 4: That the Superintendent or his designee shall also personally deliver, with receipt, a written notice of dismissal to the educational support personnel at least **thirty (30) days** before the employees' last day of employment, which notice shall be substantially as set forth in the Exhibits attached hereto.

Section 5: That this Resolution shall be in full force and effect forthwith upon its passage.
