Re: **Amendment to Food Service Management Company Contract**

Carol Baker:

This letter (this "**Letter Amendment**") will confirm the understanding between you and our representatives that, effective as of July 1, 2019, the Contract for Food Management Services between Urbana School District #116 (the "**SFA**") and Aramark Educational Services, LLC ("**Aramark**"), effective July 1, 2019, as amended from time to time (the "**Agreement**"), shall be further amended as follows:

1. **Terms and Termination**. The parties agree that the term of the Agreement shall be extended for a one-month period, commencing on June 30, 2019 and continuing through July 31, 2019.
2. **Per Meal Prices**. The parties agree that the per meal prices charged to the SFA by Aramark shall be the prices set forth on Attachment A below. These prices shall be effective from July 1, 2019 through July 31, 2019, and shall supersede in all respects the per meal prices in any other prior agreements between the parties. In the event that the Illinois State Board of Education ("**ISBE**") or the United States Department of Agriculture ("**USDA**") denies or claws back any claim for reimbursement under the National School Lunch and Breakfast Programs, the SFA agrees it will utilize funds from outside of its nonprofit school food service account to pay Aramark the full amount of any denied or clawed back claim for reimbursement.

In all other respects, the Agreement shall remain in full force and effect. This Letter Amendment shall be attached to, and become a part of, the Agreement.

If this is consistent with your understanding of our agreement, please sign below indicating that you acknowledge and agree to the foregoing, and return a copy to me at your earliest convenience.
